LIFE TOGETHER

1. Establish committed relationships with all Newman Housing Members.

We spend time together, serve one another with our time and talents, pray for and with each other, and resolve conflict quickly and appropriately.

2. Share meals together.

Throughout the week, it is encouraged that Newman Housing Members join together and share a meal together. This can be in a small group setting or with the entire Newman Housing Community. Either a meal can be prepared for everyone, or individuals can bring their own meal and eat in community.

3. Handle our relationships with the opposite sex in a healthy & holy way.

We are committed to handling our relationships as men and women with wisdom and integrity and romantic relationships according to STM’s pastoral approach. As one expression of this, Newman Housing Members are not permitted to have visitors of the opposite sex spend the night.

4. Honor the Lord’s Day together with our Newman Housing and the STM community.

Twice per semester, Newman Housing Members will host a Lord’s Day Dinner with prayer, a formal meal, and time for fellowship. We will each participate in the meal preparation, Lord’s Day preparation, and/or cleaning after the meal for at least one Lord’s Day Dinner each semester.

STEWARDSHIP

5. Keep our Newman Housing in good order.

We are each responsible for assigned chores. We will not modify Newman Housing, either inside or outside, by painting, building, sawing, digging, hanging, nailing, or similar, without prior written permission from an STM senior staff.

PRAYER & FORMATION

7. Participate actively and faithfully together in Newman Housing Prayer.

Newman Housing Prayer includes the suggested following forms among others: Liturgy of the Hours, Praise and Worship, Rosary, Divine Mercy Chaplet, Eucharistic Adoration, as well as time for personal prayer.

8. Commit to live a life of accountability.

We will keep the commitments we have chosen to make and act in such a manner as to be above reproach. We will live our life in the light and be open to have others speak into our life. We honor and respect the service of our Newman Housing Ministers. Newman Housing Ministers are commissioned to serve the unity of our community.

9. Honor commitments to our education as BGSU students.

We recognize our vocation as a student and our responsibility to glorify the Lord through our studies. In doing so, we pursue academic excellence in union with our pursuit of spiritual wisdom and growth.

10. Attend Mass each Saturday or Sunday.

The Mass allows us to receive the Holy Eucharist, or Communion, and to put God first above all things according to the First Commandment, and to observe the holiness of the Sabbath as part of the Third Commandment. EXPECTATIONS

Housing Orientation: Newman Housing Ministers will host a MANDATORY orientation the Sunday before BGSU classes start in the fall. Orientation typically goes from 12pm (Lunch provided) and ends with 5pm mass together as a community. Orientation allows us all to prepare for the semester, grow as a community, go over important information, as well as, answer any questions anyone may have.

Chores: Members will maintain the cleanliness and sanitary levels of both individual and shared living space. This will include an assigned week to clean the kitchen and laundry room each semester.

Common Meals: Periodically have a shared/potluck style dinner (once per month or every other month).

Newman Housing Prayer and Breakfast: Community Liturgy of the Hours one morning each week as well as other community prayer opportunities and personal prayer throughout the week. Each member is expected to help with breakfast at least twice each semester.

Lord's Day Celebrations: Newman Housing Lord's Day Celebrations take place on Saturday evenings twice per semester. Each member is expected to help with one Lord's Day each semester.

NEWMAN HOUSING EVENTS

As a community, we host events that are open to everyone and we encourage you guys to make an effort to participate! It's these events that help us grow our community and serve as an outreach opportunity. We are always open to new events and initiatives that our members feel passionate about and want to have to grow in their faith with this community.

Friday Night Out: Approximately once a month, Newman Housing Members, under the guidance of Newman Housing Ministers, will host Friday Night Out in order to further engage the STM community.

Sports Night: One night a week Newman Housing Ministers will host a sports night in order to further engage the STM community.

Men's & Women's Night: Approximately once a month, Newman Housing Ministers will host a TBD event in order to future engage STM community.

GENERAL CONDUCT POLICY

STANDARDS OF APPROPRIATE CONDUCT

The general conduct policies of STM apply to all members living in Newman Housing sponsored by St. Thomas More University Parish (STM). Members of Newman Housing are personally responsible for their actions.

These policies are not meant to be exhaustive and do not cover every situation that may arise. STM reserves the right to make changes at any time, with or without prior notice, and to interpret these policies and procedures at their discretion.

1. USE OF ALCOHOL

STM Newman Housing Members are not required to abstain from alcohol use but the following restrictions are enforced:

- State law forbids the consumption of alcohol by those under the age of 21.
- Alcohol will not be used at STM outreach events where those not of legal age are present. Per law, any individual providing alcohol to an underage individual can be held responsible for the damage caused by the underage individual.
- STM Newman Housing Members who are of legal drinking age are expected to handle use of alcohol with respect and maturity. This includes avoiding language that exalts 'drinking' together. This also means that those members of legal drinking age should avoid using alcohol in a way that causes disunity and an overly exclusive approach to socializing together.

2. SEXUAL HARASSMENT

Newman Housing Members will not act in such a manner as to cause discomfort or humiliation by communication of a sexual nature, sexually explicit language, or any unwelcome physical contact.

3. CONFIDENTIALITY

Newman Housing Members will uphold the confidential nature of the information shared with them by other members and will refrain from disclosing such information to those who have no need for, or right to, that information.

4. CATHOLIC VIRTUES AND VALUES

Newman Housing Members will strive to live in accordance with the Catholic Faith, which includes, but is not limited to, conformity and agreement with teachings of the Catholic Church.

5. VISITORS

Members will respect the needs of other Newman Housing Members in the shared living space when entertaining visitors. Visitors of the opposite sex are prohibited from spending the night.

6. DAMAGES TO NEWMAN HOUSING PROPERTY

STM will issue Security Deposit Refunds approximately 6 weeks after Newman Housing Lease expiration. To document and calculate need for withholding funds from Damage Deposit, STM senior staff will conduct two (2) assessments of Newman Housing properties and consult with the Newman Housing Ministers and the Pastor beginning one (1) month prior to the end of current academic year.

1st Assessment: STM senior staff will visit the property and assess whether there are any damages that still need to be addressed. At this time, a VERY detailed cleaning list will be given to the Newman Housing Ministers to delegate amongst the members. If the Newman Housing Members do not satisfactorily clean the property themselves, STM will hire a cleaning crew and any cleaning charges that are incurred will be taken out of all the members' damage deposit.

2nd Assessment: Approximately three weeks following 1st Assessment, any damages and all cleaning responsibilities that were noted in the initial assessment will be inspected. A decision will be made with the STM senior staff and the Newman Housing Ministers as to what amount (if any) should be assessed from the security deposits. Any cleaning charges assessed from security deposits will be billed equally across all Newman Housing Members, including staff, regardless of time and effort put into cleaning. The members of the Newman Housing are in it together. Note, however, that an individual may be individually assessed for damage that they, specifically, are responsible for. Newman Housing Members are always expected to repair/replace damages for which they are responsible. It is preferred that these happen out of pocket from the Newman Housing Member rather than STM needing to do the work necessary to repair said damages.

INAPPROPRIATE CONDUCT

Recognizing that living in Newman Housing carries with it responsibility for appropriate behavior, STM will not tolerate inappropriate behavior as outlined in this document. Without excluding other grounds, any of the following may be considered grounds for disciplinary action or removal from the Newman Housing premises:

- Misusing, destroying, or damaging any Newman Housing property or property belonging to individual Newman Housing Members. NOTE: Newman Housing Members will be held financially responsible for such damage.
- Engaging in behavior designed to create discord among Newman Housing Members, or willfully withholding participation, or encouraging others to engage in such behavior.
- Conditions or situations that create discord among Newman Housing Members, results in an inability to live out the commitments, or places undue stress on members' lives.
- Any immoral, disorderly, or indecent conduct toward another Newman Housing Member and/or STM participants, including the use of abusive, profane, or threatening language.
- Lack of satisfactory participation in Newman Housing commitments.
- Consuming drugs with the intent of intoxication, or using or possessing illegal drugs or drug paraphernalia on STM and Newman Housing premises or at any STM events.
- Alcohol and other substance abuse.
- Any acts of sexual abuse, sexual exploitation, and/or sexual harassment.
- Engaging in slander, gossip, or spreading rumors regarding other Newman Housing Members, the Catholic Church, or St. Thomas More University Parish in general.

INVESTIGATIVE ACTION

If a Newman Housing Member is accused of inappropriate behavior, it is the policy of STM to investigate all accusations of wrongdoing. All investigations will be dealt with according to the following standards:

- All facts will be carefully reviewed by the Newman Housing Ministers and if necessary the Pastor; the Newman Housing Member will be given full opportunity to explain his/her conduct before any decision is reached.
- In the case of alleged serious misconduct where an accusation has been made against a Newman Housing Member, that Member will face an immediate 3-5 day removal from Newman Housing and STM property. A proper investigation will follow.
- If the investigation determines a breach of the standards of conduct listed above, the Pastor will issue either a probation or a discharge. For a probation, the Newman Housing Member will be prohibited from residential living spaces on the STM property for a period of six months upon the issue of the probation. The Newman Housing Member will then need to provide the Pastor with concrete evidence of efforts towards changing and improving behavior. In the event of a discharge, a removal from the STM property will take effect immediately. The Newman Housing Member must leave Newman Housing, return all STM property, and remove all of their personal belongings from the premises.
